Overall Performance

- So far, international tourist arrivals for 2021 were reported by 20 destinations. For their reporting periods, all destinations recorded declines in tourist arrivals.
- For the period January to March, the 13 reporting destinations registered declines in international tourist trips with the best relative performances being recorded in the US Virgin Islands (-26.9%) and followed by Aruba and the Dominican Republic (-50.9% each), St. Maarten (-53.5%) and Antigua & Barbuda (-74.0%). The remaining eight destinations recorded declines ranging between -75.4% (Belize) and -98.6% (Trinidad & Tobago).
- For the period January to February, six destinations recorded decreases in tourist arrivals, the smallest of which was registered in Martinique (-54.9%). The contractions in arrivals in the other destinations reporting for this period varied from -72.9% in Guyana to -92.6% in St. Kitts & Nevis.
- Bermuda was the only destination reporting for January only, registering a -90.2% decline in stay-over arrivals for the month.

By Month

- In January, 20 destinations reported international tourist visits. The lowest percentage decrease in tourist arrivals during this month was recorded in Martinique (-39.7%) followed by the US Virgin Islands (-40.3%) and St. Maarten (-60.3%). Other decreases logged during this month ranged between -63.2% in the Dominican Republic and -98.7% in Trinidad & Tobago.
- The 19 reporting destinations recorded declines in tourist arrivals in February. The US Virgin Islands (-33.4%) registered the best performance this month trailed by the Dominican Republic (-64.9%) and Aruba (-66.4%). Trinidad & Tobago (-99.1%) recorded the largest percentage decrease during the month followed by Grenada (-96.6%).
- Four destinations out of the 13 reporting arrival data for March registered growth, while declines were recorded in the remaining nine destinations. Aruba (14.3%), the US Virgins Islands (11.9%), St. Maarten (6.0%) and the Dominican Republic (3.6%) were the destinations recording increases, while decreases ranged from -35.5% in Belize to -97.4% in Montserrat.

By Market

United States

- International tourist arrivals from the United States decreased in the 18 reporting destinations.
- For the period January to March, the 12 reporting destinations recorded decreases in visitor trips from the United States led by Trinidad & Tobago (-99.0%) and followed by Cuba (-95.3%) and Montserrat (-94.0%). The Dominican Republic registered the smallest falloff (-31.1%) in arrivals from this market among the destinations this period.
- Declines in international arrivals from the United States were recorded in all five destinations reporting for the period January to February, with Guyana (-49.6%) registering the best relative outcome. This was followed by Jamaica (-73.1%), The Bahamas (-81.5%), Anguilla (-87.5%) and St. Kitts & Nevis (-91.0%).
- Arrivals from the United States decreased in Bermuda by -90.8%, the only destination reporting arrival data for January only.

Canada

- Visitor trips to the region from Canada decreased in the 18 reporting destinations.
- Each of the 12 destinations reporting international arrivals from Canada for the period January to March recorded reduced visitation exceeding -90.0%. St. Maarten (-94.8%) recorded the best performance followed by Dominica (-95.4%) and Aruba (-95.6%).
- Each of the five destinations reporting international arrivals from Canada for the period January to February recorded a decline. These falloffs in arrivals ranged from -79.8% (Guyana) to -98.0% (The Bahamas).
- Bermuda, the lone destination reporting for January only, saw a decrease of -93.1% in visitor trips from Canada.

Europe

- Overall, international tourist trips from Europe decreased in the 18 reporting destinations.
- Contractions in arrivals from the European market were recorded in the 12 destinations reporting for the period January to March. The declines recorded in these destinations ranged from -46.8% in St. Maarten to -97.7% in both Grenada and Trinidad & Tobago.
- For the period January to February, European arrivals to the region decreased in the five reporting destinations between -72.2% in Guyana to -98.9% in Jamaica.
- A decline in arrivals from Europe was recorded in Bermuda (-84.8%) during January only, the only destination reporting for this time.

Cruise Arrivals

- Cruise visits to the Caribbean contracted in the 15 reporting destinations, so far, this year.
- No cruise ship has sailed the Caribbean to date. Consequently, for all reporting destinations and period, the decline in cruise arrivals is -100.0%.
