Overall Performance

- Out of the 26 destinations reporting international arrivals for 2021 so far, growth was recorded in 15, while another 11 registered declines in their reporting periods.
- For the period January to December, 15 destinations out of the 26 reported growth in stay-over arrivals. The Turks & Caicos Islands (145.9%) recorded the largest percentage increase and was trailed by St. Maarten (133.8%), Aruba (119.0%), Puerto Rico (108.4%) and the Dominican Republic (107.6%), while the remaining ten destinations with increases grew by between 11.8% (Anguilla) and 102.7% (the Bahamas). Arrivals declined during this time in ten destinations ranging from -3.9% in Grenada to -85.8% in the Cayman Islands.

By Month

- In January, 26 destinations reported international tourist visits. The lowest percentage decrease in tourist arrivals during this month was recorded in Martinique (-34.5%) followed by the US Virgin Islands (-39.7%), Puerto Rico (-47.7%) and St. Maarten (-60.3%). Other decreases logged during this month ranged between -63.2% in the Dominican Republic and -98.7% in Trinidad & Tobago.
- The 26 reporting destinations recorded declines in tourist arrivals in February. The US Virgin Islands (-15.8%) registered the best performance this month trailed by Puerto Rico (-33.7%), the Dominican Republic (-64.9%) and Aruba (-66.4%). Trinidad & Tobago (-99.1%), the Cayman Islands (-98.9%) and the British Virgin Islands (-98.3%) recorded the largest percentage decreases during the month.
- Six destinations out of the 26 reporting arrival data for March registered growth, while declines were recorded in the remaining 20 destinations. The US Virgin Islands (110.5%), Puerto Rico (80.0%), the Dominican Republic (16.0%), Aruba (14.3%), St. Maarten (6.0%) and Guyana (4.2%) were the destinations recording increases, while decreases ranged from -3.9% in the Turks & Caicos Islands to -97.4% in both the Cayman Islands and Montserrat.
- All 26 destinations reporting arrivals for April registered significant increases compared to the same month in 2020 in which tourism activity globally was curtailed. The US Virgin Islands (65.8%) and Puerto Rico (9.0%) were the only destinations to have arrivals exceed their 2019 numbers. All other results were below the 2019 level of arrivals by between -35.6% (the Turks & Caicos Islands) and -98.7% (the Cayman Islands).
- Similarly, tourist visits bounced back in the 26 destinations reporting data for May when compared to May 2020. However, except for the US Virgin Islands (up 46.2%) and Puerto Rico (up 18.6%), these performances still trailed the outcomes in May 2019 by upwards of -98.4% (Trinidad & Tobago). Both Puerto Rico and the US Virgin Islands achieved a historical high for May.
- Further improvements in arrival levels were seen among the 26 destinations submitting data for June relative to June 2020. Again, tourist arrivals to the US Virgin Islands (47.8%) and Puerto Rico (32.3%) were more than in the corresponding month in 2019. The Turks & Caicos Islands (2.3%) also recorded an increase over its June 2019 tourist arrival figure. New records for this month were attained by the US Virgin Islands and the Turks & Caicos Islands. Of the other destinations, St. Maarten (-9.6%), Aruba (-14.5%), the Dominican Republic (-21.2%), Antigua & Barbuda (-30.4%) and Jamaica (-30.5%) had the best results when compared to June 2019.
- In July, growth in arrivals was recorded in the 26 reporting destinations compared to July 2020.
 Antigua & Barbuda, Puerto Rico, St. Maarten, the Turks & Caicos Islands (with a new record) and the

US Virgin Islands (also with a new record) exceeded their pre-pandemic arrival levels. While arrivals to the US Virgin Islands rose by 57.2% and those to Puerto Rico and the Turks & Caicos Islands jumped by 45.0% and 18.9% respectively, when compared to those in July 2019, a 1.6% increase was recorded in each of the other two destinations. In the other 21 destinations, the rates of decline relative to 2019 continued to fall and ranged from -3.2% in Aruba to -98.1% in the Cayman Islands.

- The Turks & Caicos Islands and the US Virgin Islands achieved new record levels of arrivals for August. However, all 26 destinations reporting tourist trips for this month registered growth of between 19.0% (Martinique) and 6,826.3% (Anguilla) when compared to August 2020. The US Virgin Islands (32.4%), the Turks & Caicos Islands (15.2%), Puerto Rico (8.8%) and Antigua & Barbuda (6.4%) were the only four destinations to record increased arrivals compared to August 2019. Declines recorded in the other reporting destinations were between -3.0% (St. Maarten) and -98.2% (the Cayman Islands).
- Visitor arrivals reported in September showed that 25 of the 26 destinations recorded increases when compared to September 2020 ranging from 75.9% in Montserrat and 1,413.6% in Belize. Martinique (-2.3%) was the lone destination to register a decrease. However, matched against the arrivals in the corresponding month of 2019, contractions in arrivals were recorded in 22 of these destinations where declines varied from -13.6% (St. Maarten) to -95.9% (the Cayman Islands). The Turks & Caicos Islands (44.9%), the US Virgin Islands (38.1%), the Dominican Republic (12.9%) and Puerto Rico (6.2%) did better in September 2021 than in September 2019. The Dominican Republic, Puerto Rico and the Turks & Caicos Islands each achieved a historical high for this month.
- New records in arrivals for October were realized by the Dominican Republic and the Turks & Caicos Islands which were among the 26 destinations reporting increased tourist visits of between 11.6% (Martinique) and 1,997.1% (St. Kitts & Nevis) for the month. When the arrivals were compared to October 2019, only the US Virgin Islands (61.7%), the Turks & Caicos Islands (25.1%), the Dominican Republic (19.0%), Puerto Rico (11.2%) and Curação (1.4%) achieved better results. The other 21 reporting destinations were in deficit by at least -10.0%.
- Growth in tourist arrivals was registered by the 26 destinations reporting for November led by Trinidad & Tobago (1,712.9%) followed by The Bahamas (1,212.8%), St. Kitts & Nevis (721.9%) and Anguilla (621.3%). Despite this, only in the US Virgin Islands (32.9%), the Dominican Republic (12.4%), St. Maarten (12.2%), the Turks & Caicos Islands (2.7%) and Puerto Rico (2.4%) were increases in arrivals, compared to the corresponding month in 2019, realized. Declines recorded in the remaining 21 destinations ranged from -1.9% in Curação to -94.7% in the Cayman Islands. New records for tourist visits in November were set in the Dominican Republic, the Turks & Caicos Islands and the US Virgin Islands.
- Increases were recorded in the 26 destinations reporting international arrivals for December. Trinidad & Tobago (3,517.3%) recorded the largest percentage increase for the month and was followed by the British Virgin Islands (832.2%), the Cayman Islands (693.9%) and St. Kitts & Nevis (677.7%). The other destinations registered growth ranging from 49.4% (Martinique) to 485.1% (The Bahamas). Against their 2019 tourist arrivals, the US Virgin Islands, the Dominican Republic, and St. Maarten registered increases of 25.8%, 16.7% and 12.8%, respectively. All other destinations did not improve upon their 2019 performances. The outcomes in the Dominican Republic and the US Virgin Islands broke their previous records.

By Market¹

United States

- International trips from the United States grew in 17 of the 22 reporting destinations overall and contracted in five destinations.
- Out of the 21 destinations reporting international tourist trips from the United States for the period January to December, 16 recorded increases ranging from 3.7% in Barbados to 194.3% in St. Maarten.
 Declines in the five remaining destinations varied between -21.1% in St. Kitts & Nevis and -90.4% in the Cayman Islands.
- A 55.0% increase in tourist arrivals from the United States for the period January to June was registered in the lone reporting destination, the Turks & Caicos Islands.

Canada

- Visitor trips to the region from Canada increased in one out of the 22 reporting destinations, while 21 destinations recorded declines from this market.
- Except for Guyana, which posted a 51.5% increase, fewer international trips from Canada were recorded in the 21 reporting destinations during the period January to December. St. Maarten (-7.6%), Bermuda (-28.8%), Aruba (-34.4%), Grenada (-39.9%) and Anguilla (-40.1%) recorded the best relative performances among the destinations. For this period, Cuba (-91.0%) registered the largest contraction.
- Reporting for January to June, the Turks & Caicos Islands registered a decrease in arrivals from Canada of -86.6%.

Europe

- Overall, international tourist trips from Europe increased in nine out of the 22 reporting destinations and decreased in 13.
- Visitor arrivals from Europe increased in nine of the 21 destinations reporting for the period January to December led by the Dominican Republic (115.5%) and trailed by St. Maarten (92.7%) and Aruba (90.4%). Contractions among the remaining destinations from this market during this time ranged between -19.5% (Barbados) and -65.3% (Montserrat).
- The lone reporting destination for the January to June period was the Turks & Caicos Islands, registering a falloff in tourist arrivals from Europe of -24.8%.

Cruise Arrivals

- Cruise visits grew in one of the 23 reporting destinations, while contractions were reported in the other 22 Caribbean destinations, so far, this year.
- Cruise visits for the January to December period grew in one of the 21 reporting destinations, namely, Bermuda (27.7%). The Dominican Republic reported the smallest decrease in cruise visits among the other 20 reporting destinations in which decreases ranged between -3.3% and -100.0% (the Cayman Islands, Martinique and Trinidad & Tobago). The Bahamas received 1.1 million cruise visits, the most in any destination and was followed by Cozumel with 0.7 million cruise arrivals.
- Puerto Rico was the only destination reporting for the period January to November, registering a -80.6% decline in cruise arrivals for this period.
- For the period January to June, the lone reporting destination, the Turks & Caicos Islands, recorded a decrease in cruise visits of -100.0%.
