- Experience with qualitative research and semi structured interviews
- 5 years of graduate research and/or community activity experience

#### **UWI-SALISES Profile:**

The UWI has, as part of this mission recently signed, in September 2020, a landmark Memorandum of Understanding with the Open Society Foundations, to advance the work on climate change, racial justice and a deepening of democracy.

The Sir Arthur Lewis Institute of Social and Economic Studies (SALISES) is a Research Centre of The University of the West Indies (UWI). SALISES was founded in 2000 through the merger of the Institute of Social and Economic Studies (ISER) and the Consortium Graduate School of Graduate Studies (CGSS). Since its inception as ISER in 1948, SALISES has developed and maintained a strong culture of quality research that has been used throughout Jamaica and the Caribbean for program and policy development. Research fellows trained in research, policy formulation and analysis are employed by the Institute. #### **PROJECT DESCRIPTION**

The project identifies, maps and brings together (digitally and in presence) Caribbean communities, associations, NGOs and activists groups that have been organizing and resisting against the expansion of disaster capitalism in the region. In particular, it relies on four pillars: identification, communication, visibility and construction of stronger and long-lasting networks. After 18 months, the project will have identified at least twenty different actors across the region, promoted at least 15 collective online meetings to share their stories and experiences, made them visible on easily accessible and dynamic open access platforms, and organized the first collective regional workshop of actors at the frontline of the fight against disaster capitalism. This project will thus reinforce already existing processes, establish solid and long-lasting regional networks and conversations, increase mutual learning, facilitate knowledge transfer and experience sharing. In coordination with the work proposed by Global Legal Action Network (GLAN) and Climate Litigation Accelerator (CLX), DisCC will also promote the access to local realities by international actors operating in the area of legal advocacy and legal support and offer a unique form of support in the unfolding and reproduction of legal and non-legal strategies at the local, national, regional and international level.

| DESCRIPTION OF DUTIES                               | <ul> <li>Map existing and past relevant struggles for territorial and climate justice in the Caribbean and the organizations, indigenous people, individuals, etc. who were behind them</li> <li>Establish contact with these organizations and involve them in the network;</li> <li>Establish a relationship of trust with the current five local partners of the GCRF project and the partners in Haiti and Grenada, so to leverage their knowledge and experience to best define the next steps of the project;</li> <li>Gather, systematize and upload information coming from the new members of the network and assist the webdeveloper in populating the website and gathering the relevant information to appear on it;</li> <li>Organize at least one interaction per month of all members of the network and a system of online safe repositories to share documents, information, etc.;</li> <li>Maintain the connections with GLAN, CLX and the other partners that will be involved in the process for legal advocacy and legal education. The intermediation by the regional post-doc research will make sure that international organizations do not bypass the horizontal structure of the network and that all parties feel equally involved.</li> <li>Invite academics and international partners (legal and nonlegal) to participate in ad hoc meetings with the network to provide further support around specific themes, issues and strategies;</li> <li>Organize at least one online conference/workshop every six months in order to give further visibility to the network and what it is achieving;</li> <li>Draft reports of the interactions, to be shared with all participants;</li> </ul> |

- Organize one two-day in person workshop in Jamaica to be held in the last quarter of the project. One representative per organization/actor will be invited to the workshop, the first of its kind, along with representatives of the international organizations providing legal support and selected environmental lawyers (see below for further details). This three day workshop will provide participants with the opportunity to meet, strengthen personal connections, facilitate the exchange of information, intensify their legal knowledge and education, think collectively about regional actions and strategies, and identify joint pathways for the longer term.
- Draft a report on the workshop highlighting procedure, findings, dynamics, etc.
- Draft a policy brief containing the most relevant proposals coming from the monthly interactions and the workshop.
- Provide communication support to project involving community partners
- Support with interpretation during online consortium meetings (not at professional level)
